Currently, Wage Order #24 in effect, which for Webster County lists an hourly rate for Truck Drivers of \$19.45 per hour, plus \$4.72 for fringe benefits (total of \$24.17 per hour). However, should a new Wage Order come into effect, the new wage rate(s) should be used.
