CONSTITUTIONAL AMENDMENT NO. 2
<i>Proposed by Initiative Petition</i>
Do you want to amend the Missouri Constitution to:
<ul style="list-style-type: none"> • adopt Medicaid Expansion for persons 19 to 64 years old with an income level at or below 133% of the federal poverty level, as set forth in the Affordable Care Act; • prohibit placing greater or additional burdens on eligibility or enrollment standards, methodologies or practices on persons covered under Medicaid Expansion than on any other population eligible for Medicaid; and • require state agencies to take all actions necessary to maximize federal financial participation in funding medical assistance under Medicaid Expansion?
State government entities are estimated to have one-time costs of approximately \$6.4 million and an unknown annual net fiscal impact by 2026 ranging from increased costs of at least \$200 million to savings of \$1 billion. Local governments expect costs to decrease by an unknown amount.
